Any unpaid balances are subject to a 5% interest charge per month payment is overdue beginning September 1, 2009. Should the total amount of the seasonal court not be received by September 1, 2009, the Club has the right to cancel the seasonal reservation.

## TERMS & CONDITIONS:

### COURT CONTRACT

1. A non-refundable deposit of \$500.00 per court hour is required to reserve the court for the season. If you do not leave a deposit, your court is not guaranteed. Deposits are due no later than April 1, 2009. If deposits are not received by April 1, 2009, the club will then open up the court time for resale. Deposits are Non-Refundable after June 1, 2009. Any unpaid balances are subject to a 5% interest charge per month payment is overdue beginning September 1, 2009. Should the total amount of the seasonal court not be received by September 1, 2009 HVHTC has the right to cancel the seasonal reservation.
2. Captains are responsible for collection of all payments. HVHTC requires payments made in full by the court captain after they have collected total funds. Only one group Captain will be billed and that captain is responsible for payment in full. Each court captain is required to sign the court reservation contract.
3. Captains will be responsible for supplying the club with a completed application including the name, address and telephone number of all the players in the group.
4. Refunds will be granted on a prorated basis only if the court is resold.
5. When HVHTC is responsible for loss of playing time by reason of emergency conditions, make up time will be scheduled with the group captain based on court availability. **Seasonal time, unused because of personal reasons by the playing group can not be made up.**
6. HVHTC reserves the right to preempt court time when necessary. HVHTC will allocate make up time based on court availability.
7. HVHTC reserves the right to make court assignments and changes when it is deemed necessary.
8. HVHTC reserves the right to terminate this agreement at any time for unsportsmanlike conduct on the part of the player(s) or any other reason deemed to be good and sufficient by the Club's management, in which event the unexpired prorated portion of the player's rental payment shall be returned to the player(s) and neither the Club nor the player(s) shall be under any further liability on account of the agreement. No refunds will be made to any player except as provided in this paragraph.
9. The use of court beyond the assigned time will be subject to charge as per specified by open court time rates.
10. HVHTC is not responsible for any player's personal property regardless of how or where it is stored and when it is discovered missing.
11. Players must provide supervision for children under age 12.
12. Proper tennis attire and appropriate tennis shoes are required at all times.
13. Should it ever be determined that Federal, State or Local tax be levied, the group members jointly agree to be responsible for prompt payment of their taxes.
14. Use of the courts and the Club's facility are strictly at the player's own risk. The Club is not responsible for accidents occurring as a result of normal use of the facilities.
15. A 5% discount will be given to Captains who pay for their court IN FULL on or before March 25, 2009. A 10% discount will be given to Captains who pay for their court IN FULL on or before March 1, 2009. Also, if you are renewing your court this year, and we receive your deposit/payment in full no later than April 1, 2009, you will receive an additional 3% off the cost of your court. NO EXCEPTIONS will be made after these dates.
